ⁱ Applies to studies where all preliminary work is completed by the investigator including collection, labeling, processing, centrifuging and placing sample into appropriate containers/cups ready for loading onto a lab analyzer. The appropriate analyzer containers/cups will be provided by the laboratory. The samples must be labeled and assurance must be provided that non-laboratory staff collecting and centrifuging blood specimens meet Laboratory Standard Operating Procedures for the blood collection and sample preparation. The samples will not be logged into the Lab Information System. Samples must be batched. Analyzer printouts containing results will be provided to the investigator who will be responsible for data transfer.
